Application deadline: September 15

Performance period: January 1 through December 31

West Virginia Rivers Coalition Mini-Grant Program

Eligibility: Intended for community-based organizations with budgets under \$100,000/year that seek to lead activities with an emphasis on grassroots activism and advocacy. Awards are available up to \$2,500.

Criteria: Activities must occur in WV; empower and engage citizens through activism and advocacy; align with one of our priority focus areas below; and be completed within 1 year.

Potential Projects: Event, training, petition drive, advocacy campaign, community organizing, or other project that empowers citizens to take action for clean water in West Virginia.

Up to \$3,000

Try This WV emphasizes healthy activity.

It fits with trail and water-trail activities.

It has been used to set up weekly paddling meet-ups, even buying kayaks.

Clean Water Act Nonpoint Source Program—§319

Larger projects, agenda is more constrained.

Money for projects that decrease nonpoint source pollution.

Federal money administered by state! Lots of requirements!


Amounts can be substantial.

Requires matching resources!

Three to four year timeline.

Allows some operating costs.

Clean Water Act Funding is part of a long chain of steps set up by the Clean Water Act.




Total Maximum Daily Loads (TMDL)

How much pollution (e.g., kg/day) can a stream receive before it fails to meet standards?

TMDLs determine what amount of the pollution load is Point Source, and what amount is Nonpoint Source.

Point Source pollution is addressed by modifying Discharge Permits.

Nonpoint Source pollution is addressed by encouraging installation of best management practices (BMPs)



A Nonpoint Source pollution project should

Reduce pollution to a particular stream.

Cause a stream segment to stop violating water quality standards.

Have operations and maintenance covered by a different resource or partner.

Supply 40% of the resources for the grant.

Be completed within the performance period.

Funding is reimbursed, not provided up front.

Timeline:

Federal FY2025 10/1/2024-9/30/2025

For FY26 funds, apply
5/1/2025 Submit application
10/1/2026 +/- Funding available
9/30/2030 Drop Dead Deadline
to finish project.

For Watershed Based Plan funding, get in touch with your Basin Coordinator, and the WVDEP Nonpoint Source Program Coordinator.

Office of Surface Mining Reclamation and Enforcement Watershed Cooperative Agreement Program (WCAP)

- Nonprofit organizations are eligible. In fact, the program is officially called "Not-for-Profit AMD Reclamation." The program is for non-profits.
- The WCAP goal is to supply only 40% of the resources, as if it is tailored to fill the 60:40 requirement for NPS funding.*
- The contact in West Virginia is Chris Hayner (<u>CHayner@osmre.gov</u>).
- Requirements and instructructions are in <u>Directive GMT-10 Federal Financial</u>
 <u>Assistance Manual</u> (starting on page A-250).
- Funding is mainly for construction.
- Requirements call for one year of monitoring before you apply.


